Distribution boxes shall be made of non-combustible materials; open distribution boards may be installed in production places and offices with low electric shock risk; enclosed cabinets shall be installed in processing workshops, foundries, forging, heat treatment, boiler rooms, woodworking houses. The National Electrical Code (NEC) provides comprehensive safety standards for electrical installations, including requirements for electrical panels (main service panels and subpanels or breaker box).
